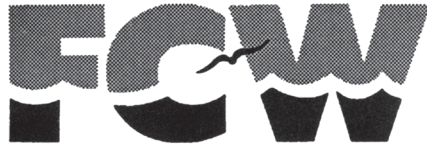

**Paul Parker** is the Director of the Cape Cod Fisheries Trust. He was the Executive Director of the Cape Cod Commercial Hook Fisherman's Association from 1998 to 2008 when he was instrumental in setting up the Fisheries Trust. He has a BA in biology from Cornell and a Masters in Environmental Management from Duke University. The Trust's goal in the next 3-5 years is to raise \$10 million to buy ground fish, scallop and lobster permits to lease them to qualifying Cape Cod fishermen, in order to revitalize coastal fishing communities.

**WAYNE JOSTRAND:** Wayne has BE, ME and DE degrees from Yale University. Following a career as an Executive Manager in high technology industries, including IBM, Nortel & Iomega and in Executive Management Consulting with CAP Gemini, and Riverside Consulting Group. He and his wife Emily, retired to Chatham in 2000. Wayne is former Chairman of Chatham's Planning Board and currently is a member of the Operating Board of the Chatham Historical Society. His interests include – boating, running, golf, wood-working and classical music.

**MICHAEL WESTGATE:** Michael's Chatham connection began 1940. Sailing was the center of his summers through 1958 when he was sailing instructor at SHYC. A graduate of Swarthmore College and Newport Officer Candidate School, Michael spent three years as Combat Info Center Officer and Navigator on the *USS Vogelgesang* engaged in Atlantic Fleet anti-submarine exercises. He worked in NYC as Asst. Commissioner of Ports & Terminals, in D.C. with the Federal Home Loan Bank Board after Harvard Business School, and in Boston where he ran the city's economic development agency. He currently serves on CCCHFA's Board of Director's as Treasurer and has just completed a book, **GALE FORCE – Gale Cincotta: The Fight for Disclosure and Community Reinvestment.**
